A longtime educator committed to student success, Dr. William "Bill" Fiege became Brightpoint Community College's eighth president in January 2024.

Before being named as Brightpoint's leader, Dr. Fiege served for nearly 12 years as the college's vice president of learning and student success, overseeing operations for academic and student affairs. Prior to coming to Brightpoint, he held a variety of positions at Germanna Community College and Longwood University, including division dean, speech communications faculty member, assistant director of alumni relations, and assistant director of athletics.

Dr. Fiege completed a bachelor's degree in political science at Longwood University; master's degree in speech communication from Bloomsburg University; and Ph.D. in community college leadership through Old Dominion University. He is currently a member of the ChamberRVA Board of Directors, Virginia's Gateway Region Board of Directors, and the Longwood University Real Estate Foundation. He also coaches the Ironbridge National travel softball team.

He and his wife, Renee, have two teenage daughters, both of whom are taking classes at Brightpoint with the goal of completing the uniform certificate of general studies before graduating from high school.

## Dr. David Dové



As chancellor of Virginia's Community College System, Dr. David Doré provides day-to-day leadership for a system comprised of twenty-three colleges that serves more than 200,000 degree-seeking and workforce-career training students annually.

Like so many community college students, Dr. Doré is a first-generation college student. His decades-long career has been guided by a fundamental belief that every learner can be successful. His commitment to serving diverse and underrepresented populations to foster inclusive learning communities, supporting open access, student success, and economic mobility is both palpable and unwavering.

A self-described student advocate, Dr. Doré is laser-focused on recruiting the "New Majority of learners" — those twenty-five and older who face limited job prospects because they lack post-high school credentials.

Before taking the reins at the Virginia Community College System, Dr. Doré served as President of Campuses and Executive Vice Chancellor at Pima Community College. There, he led the college's five campuses and workforce development initiatives.

Dr. Doré has also served in higher education leadership positions in Tempe, Arizona and San Francisco, California.

Doré earned his Doctor of Education degree at Pepperdine University; master's degrees at Georgetown University, Boston College, and Santa Clara University; an advanced degree in Philosophy from Gonzaga University; and his bachelor's degree from Gannon University.

Named a Presidential Fellow of the Aspen Institute's College Excellence Program in 2017, Dr. Doré is active in community leadership and is a staunch proponent of community college education at the state and national levels.

Dr. David Doré is the tenth chancellor to lead the Virginia Community College System, which was founded in 1966.

Dr. Edward "Ted" Raspiller



Dr. Edward "Ted" Raspiller joined Commonwealth Savers in February, 2023. Prior to joining Commonwealth Savers he served as the president of Brightpoint Community College from 2013-2023. He has over three decades of experience in higher education access and affordability that includes roles in college leadership and administration; teaching; workforce development; fundraising; and counseling. Prior to Brightpoint, he served as president of Blinn College's Brazos County Campuses in Texas. Prior to that, Dr. Raspiller served as the graduate program director of Old Dominion University's (ODU) Community College Leadership Program; as chair of ODU's Department of Educational Foundations and Leadership; and as a member of ODU's faculty.

## Dr. Dan C. Wilson



Dr. Wilson has four decades of post-secondary educational experience. During his career, he served as the interim senior vice chancellor for academic and workforce programs at Virginia's Community Colleges (VCC). He provided support for the 23 community colleges across the Commonwealth during his tenure while serving as the chief academic and workforce development administrator. Prior to assuming that role, Dr. Wilson served as the associate vice chancellor for student experience and strategic initiatives. Dr. Wilson also held the position of associate vice president for student learning and success for the 58 colleges that form the North Carolina Community College System. Prior to that, he served as the vice president for

student services at Forsyth Technical Community College. In addition to his roles in community college education, he has held several leadership positions at four-year institutions including Winston-Salem State and Western Carolina Universities.

One of the highlights of Dr. Wilson's career was the opportunity to serve as the interim president of Brightpoint Community College during the 2023 academic year. As a newly minted VCC retiree, Van enjoys traveling, reading, and spending lots of time on the James River. Dr. Wilson is married to Anne N. Wilson, a marketing executive. They have two adult daughters, Christin and Haleigh.
