

SEVP policy allows for the electronic transmission of your I-20. Unless you request otherwise (and pay for the courier cost), your I-20 and International Student Acceptance letter will be sent to you electronically. Please advise us if you want a hard copy of these forms. Do NOT just pay for the courier without first talking to us about whether an I-20 is possible, what the path is to secure one, and whether paying for the courier process is advisable. For reasons of privacy and public policy/law, we will send your I-20 to your e-mail address of record. We cannot send it to the address of a third party. (Check one of the following)

- $\Box$  Please just send my I-20 electronically.
- In addition to the electronic copy, I would also like a hard copy of the form (please talk to the Office of International Student Services *prior* to paying for the courier services). This is true both for domestic and international addresses. If you choose this route, you must, first, certify that you live at that address.
- □ I will come in person to pick up my I-20. (Photo ID will be required). Please note that this option is subject to change.
